New Health Authority for Smith County Tyler, Texas (March 22, 2023)

Dr. Valerie B. Smith has been officially appointed by the Smith County Commissioner's Court and by the Tyler City Council to serve as the new Health Authority for Smith County.

With this appointment, Dr. Smith becomes the first female Health Authority for Smith County.

"Health Authorities are medical physicians who are appointed to administer state and local laws relating to public health within the appointing body's jurisdiction," says George Roberts, Chief Executive Officer of NET Health. The duties of an appointed Health Authority include:

- Disease prevention and suppression efforts
- Aiding local health boards or departments in quarantine inspections
- Establishing, maintaining, and enforcing jurisdictional quarantine orders
- Reporting the presence of contagious or infectious diseases to local and state authorities

Dr. Smith is an assistant professor of pediatrics with the School of Medicine at UT Tyler, and she previously practiced pediatrics for nearly 20 years at St. Paul's Children's Services in Tyler.

She also holds leadership positions with the Smith County Food Security Council, the Texas Pediatric Society, the Texas Medical Association, the American Academy of Pediatrics, the East Texas Food Bank, and Texans Care for Children.

"Through her work with Fit City Tyler, Dr. Smith introduced the Fit City 5-2-1-0 program to TylerISD and WhitehouseISD by educating teachers, students and parents about habits that promote lifelong health," continues Roberts. "She also led the "Be Our Voice" childhood obesity advocacy program that implemented evidence-based policies to improve children's health.
